

**Skye District Salmon Fishery Board** 

# <u>Minutes of the Annual General Meeting held on Thursday, 5<sup>th</sup> April 2018 at Aros</u> <u>Heritage Centre, Portree at 10.30am</u>

### Present

## 1. Convenor's Welcome

Derek Dowsett welcomed everyone to the meeting.

### 2. Apologies

#### 3. Minutes of the meeting held on 16th March 2017

Martin Leslie, seconded by Duncan Burd, proposed approval. Members agreed.

## 4. Matters Arising from Minutes

- a) <u>Discharge of Effluent near Black Rock</u>, Portree The Convenor advised that, as agreed, he had contacted both SEPA and Scottish Water requesting information following the sampling carried out. However, there had been no response. After discussion, it was agreed that he should write again, advising that if no response was received, he would be approaching the MSP for help in getting one. <u>Action point DD</u>
- b) <u>Outstanding Levy Payments</u> The Clerk advised that Peter Jarosz had provided the wording used by the Wester Ross DSFB and had followed the procedure of writing three times to each proprietor with outstanding dues and this had elicited payment of dues up to 2016 from all but 3 Estates. Of these, MacLeod Estates will be visited by Martin Leslie to see if payment can be procured without having to take court action (Duncan Burd

Mr van der Weem (North Scorrybreck) has proved elusive with the lawyers reputed to be representing him have indicated that they no longer do so. Duncan Burd offered to pass on documentation to him, and the Clerk will give him the necessary documentation. Ms Geischer (Broadford) is the other party and Duncan Burd agreed to write a letter advising her of the need for payment. <u>Action point JR and DB</u>

c) <u>*Possible Board amalgamations*</u> It was noted that any amalgamation with the Wester Ross DSFB is on hold. The variation, especially in the levy rate, between the two Boards, is problematic.

#### 5. Annual Accounts for 2017

The Clerk presented the audited accounts for 2017. The Clerk had forgotten to discuss the possible inclusion of outstanding dues with Donald Rankin's office before the 2018 accounts are prepared. Ewen MacPherson, seconded by Ian Stewart, proposed approval of the accounts. This became the finding of the meeting. It was also agreed, after discussion, that £3,000 should be passed to the Skye Fisheries Trust. <u>Action JR</u>

#### 7. Convenor's Report

Derek Dowsett urged all to stay on the alert regarding escapees from fish farms. The new farm in Uig Bay operated by Grieg Seafood Shetland Ltd had suffered the loss of fish following damage to a cage in early 2018. The fish seem to have 'vanished' and their whereabouts are unknown.

#### 8. Re-assessment of levy charged to proprietors

The current levy of 40p in the pound Sterling was considered adequate as no increase in expenditure by the Board is anticipated. It was noted that a reassessment of valuations being undertaken by the District Valuer is unlikely to be completed until later in 2018 and we should await that before considering any change.

#### 9. Any Other Competent Business

a) <u>General Effect of Fish Farms on surrounding waters</u> Martin Leslie noted that the seabed being affected by fish farms consists of 'sludge' which currents disperse over quite a wide area. He noted that, many years ago, so many lobsters were caught around Portree that local families (including that of his in-laws) had so many that they were almost fed up with them. Nowadays, none are caught in the area. It was noted that SEPA set the standards to be met. The Convenor agreed to take the matter up with SEPA. <u>Action point DD</u>
